A Chapter 11 case can be commenced on a voluntary or involuntary basis. The debtor commences a voluntary Chapter 11 case by filing a petition for relief with the clerk of a bankruptcy court. The filing of a voluntary Chapter 11 petition automatically constitutes entry of an "order for relief" opening the case. 11 USC Â§ 301.

To file a chapter 11 bankruptcy case in the Central District of California, a non-individual debtor: 1) MUST. be represented by an attorney (LBR 9011-2(a)). 2) MUST. pay the chapter 11 filing fee at the time of filing. Consult the . Court Manual. Section 1.1 for the filing fee amount and fee payment methods. 3) MUST file the following documents at the bankruptcy court in the following order (items A through D).

### **Chapter 11 Petition Package - United States Bankruptcy Court**

Should a debtor in possession fail to comply with the reporting requirements of the U.S. trustee or orders of the bankruptcy court, or fail to take the appropriate steps to bring the case to confirmation, the U.S. trustee may file a motion with the court to have the debtor's chapter 11 case converted to another chapter of the Bankruptcy Code or to have the case dismissed.
